## System z Remote Development Program

## **OVERVIEW**

The System z Remote Development Program offering provides IBM PartnerWorld members access to an IBM mainframe operating system for the purpose of developing, testing, migrating, or porting their applications. The system environments are comprised of generally available and supported operating systems and software products running as virtual guests under IBM z/VM. Each virtual guest z/OS system is dedicated to the use of the participating partner which provides a high level of system control and configuration independence within their environment.

The System z Remote Development Program offering is structured for the partner to be largely self-reliant with minimal assistance needed from IBM. Participating partners should be familiar with the chosen operating system environment and are expected to provide skills in the following areas:

- System operations
- System administration (including security)
- Application debug
- Licensing and installation of software products not provided by IBM

IBM PartnerWorld membership is a requirement for participation in the System z Remote Development Program.

Some, but not all, of the available IBM software products are included in the enrollment package. Questions regarding the availability of IBM software products not listed in the enrollment packages can be sent to <u>zRDP@us.ibm.com</u>.

## ENROLLMENT

There are two sets of enrollment forms used for the System z Remote Development Program based on location. One set of forms is for partners located in the US or Canada. The other set is for partners located in all other countries. Please refer to the program Registration Form included in the enrollment package for directions on how to submit your enrollment.

Complete the enrollment steps listed below for the offering which best suits your needs:

- Download or print the appropriate Enrollment Package
- Complete the Registration Form
- Sign the Vendor Access Agreement (US/Canada) OR the AECI Base Agreement (non-US/Canada) if your company is participating in the Remote Development Program for the first time.
- Sign the Vendor Access Agreement Exhibit (US/Canada) OR AECI Supplement (non-US/Canada)
- Complete the Program Addition Order Form (if required)
- Submit the applicable enrollment forms

#### **PROGRAM FEES**

Fees for the System z Remote Development Program are based on a minimum monthly fee and actual CPU usage as reported by z/VM. The CPU usage is measured in "work units". A work unit is the equivalent of one (1) real, non-dedicated hour of total processor time on an IBM 2003-225 processor as recorded in the VM accounting records.

The minimum monthly program fee (\$550 USD) includes initial system set-up, environmental support, up to 30 work units of CPU usage each calendar month, and 10 Gigabytes of 'user' disk (DASD) space. Work units used and user DASD required in excess of those amounts will incur additional monthly charges.

Charge for additional monthly work units used in excess of 30: \$22 USD per work unit Charge for additional DASD required in excess of 10 Gigabyte: \$10 USD per 5 Gigabyte unit

The initial billing period for this program begins when the login information is provided to you and ends last day of the calendar month. Subsequent monthly billing periods will always end on the last day of each calendar month.

#### IMPLEMENTATION

The System z Remote Development Program is provided and supported by IBM through the IBM Innovation Center located in Dallas, TX.

Participating partners are provided with sufficient resources to perform development and remote functional testing of their software. Each partner is furnished with a remote virtual operating system environment running as a second level guest system under z/VM. This provides maximum flexibility for testing new code and allows complete user control of an entire virtual processor, including system and security administration, console operations, and all required system authorizations (system key, supervisor state, etc.).

The mainframe operating systems are made available, along with other software, on IBM mainframe processors which are accessible from the Internet any where in the world.

Users of the system assume the role of system and security administrator for the virtual guest system environment and are expected to have the necessary system skills. Those skills include subsystem administration, security administration, and console operations.

Partners are also provided with z/VM hypervisor user IDs to perform virtual guest system management activities such as IPL and shutdown. In order to connect to and logon the z/VM system, a TN3270 emulator that supports SSL or TLS encrypted sessions **is required.** The TN3270 emulator is not provided by IBM and must be obtained by the partner.

Each virtual guest system is assigned an unique IP address. The IP address assigned can be either "public" (one reached directly from the internet) or "private" (reachable only by connecting to a VPN network). Developers who choose to have the system connected to the VPN network are also provided with a VPN client and a VPN sign-on ID. The VPN connection encrypts session traffic between the user and the VPN gateway.

## **PROGRAM SUPPORT**

Support for the program is provided through electronic means. The primary vehicle for support requests is the IBM PartnerWorld website which offers an easy to use application for submitting questions. Partners are encouraged to use this application so their question may be routed to the proper support team. Additional information is available on the program support website (http://dtsc.dfw.ibm.com/contact.html).

IBM software product maintenance is provided by IBM either routinely or at the request of the ISV. Routine hardware and software maintenance for the systems is performed by IBM on an ongoing basis. As such, the ability to retain a system at a particular maintenance level may not available. Requests for specific additional software maintenance are managed on a best effort basis.

Each Sunday, a maintenance-window is reserved between 9:00 AM and 3:00 PM US CT for hardware maintenance purposes. During this window, system access may not be available.

#### **PROGRAM SECURITY**

The protection of confidential and proprietary information is of the utmost importance to IBM and the Innovation Center, Dallas. The Remote Development Program is certified annually by IBM Corporate Headquarters as an Inter-Enterprise System (IES) environment, which provides extensive security for isolation of virtual guest systems.

#### SYSTEM ENVIRONMENT

The System z Remote Development Program virtual systems operate on IBM System z mainframe processors.

IBM 3590 mainframe tape drives are available for use by the with this offering. All tapes must be supplied by the user of the system, including 'scratch' tapes. The process for using and mounting tapes is described in the "User's Guide and Reference" located on the program support website (<u>http://dtsc.dfw.ibm.com/</u>).

If additional system resources or software products are required but not included on the Program Addition Order Form for the Remote Development Program, or if you have questions concerning the offering, please contact the Remote Development Program support team at <u>etpadmin@us.ibm.com</u> prior to returning the signed Remote Development Program agreement. A response will be returned as to whether the resource(s) can be made available.

The Customer and IBM agree that the following terms and conditions apply as a supplement to and amend the referenced IBM Agreement for Exchange of Confidential Information ("Agreement").

#### 1.0 Scope

1.1 Under this Supplement, IBM shall provide Customer with access via the Network to IBM z/OS V1 R10 and accompanying software products ("Software"). "Software" may include certain materials (program code and/or selected documentation) provided to Customer in tangible form.

1.1A The Customer is not eligible to use the Software provided by this Supplement on an IBM system if the Customer executes anything other than Java-language based workloads on the System z Application Assist Processor (zAAP) installed on the IBM system. In addition, the Customer may not alter the Code in any manner to affect the functionality of the zAAP.

IBM WILL:

1.2 Provide Customer real, non-dedicated CPU time on an IBM processor for access to the Software for the payment indicated below and, where IBM deems it appropriate, provide Customer with access to selected portions of the Software in tangible form for use solely in connection with this Supplement;

1.3 Provide Customer with setup instructions for the communication procedures; and

1.4 Provide a single IBM focal point for Customer problem resolution.

CUSTOMER WILL:

1.5 Provide the appropriate workstation hardware, software, modem, common telephone line and host connection charges.

1.6 Use the Software solely for the purposes of validating and migrating any Customer product(s) to the z/OS V1 R10 Software.

1.7 Not make available to third parties the Customer's z/OS V1 R10 Sofware based products developed utilizing the Software until IBM makes the z/OS V1 R10 Software generally available, except vendors and or customers which have been identified by IBM as participants in the IBM z/OS V1 R10 Early Support Program;

1.8 Ensure that it does not download or in any way attempt to obtain local access to Software provided by IBM without IBM's prior written permission. Software made available to Customer in tangible form shall be used by Customer only at Customer's facility, will be used only for the purposes of this Supplement and shall be disclosed to and used only by those Customer employees with a need to know. In addition, the Customer shall not reverse assemble, reverse compile or copy the Software in whole or part.

1.9 Take appropriate action by instruction, agreement or otherwise to ensure, prior to their initial access to Software, that Customer employees abide by the terms of this Supplement.

1.10 Provide IBM with a single development focal point.

#### 2.0 PAYMENT

2.1 Customer agrees to pay the following charge(s) for use and access to the Dedicated Fixed Monthly Cost Advanced z/OS V1 R10 Remote Development Program.

Monthly Charge: \$550 USD

This entitles the Customer to:

- 1. 1 z/OS V1 R10 virtual guest system running under IBM z/VM. The virtual guest system will be configured with 10GB of user disk and a minimum of 1GB of memory.
- 2. At least 1 z/VM User ID from which to perform virtual guest system management related activities.

- One virtual guest system logon user ID with full administration and security authority for the operating system.
- 4. Usage of up to 30 work units per month, where a work unit is the equivalent of one (1) real non-dedicated hour of total processor time on an IBM 2003-225 processor as recorded in the VM accounting records. Each additional work unit used in excess of 30 each month will be charged at the rate of \$22 USD per work unit up to a maximum work unit usage charge of \$12,000 in a single billing period.
- 5. Technical and operational support for Code as determined by IBM

Charges apply for the term of this Supplement unless IBM sends Customer written notice of a price change. IBM will send such written notice at least thirty (30) days in advance of the date that the price change becomes effective and the notice will include the effective date of the price change. After the price change you are obligated to pay the new price beginning on the effective date of the price change.

2.2 Customer has control of the IBM System on which the Customer product(s) and the Software are available for access. IBM will provide Customer with instructions for rendering the IBM System inactive when the IBM System is not in use. Customer will make the IBM System inactive when it is not in use.

2.3 Credit requests for billable work units as a result of Customer failure to render the IBM System inactive when it is not in use must be made to IBM by Customer in writing. IBM will in it's sole discretion grant or decline credits for billable work units for time periods during which the IBM System is or was active but not used by Customer. After the first work unit credit request, each subsequent credit for billable work units requested by Customer and granted by IBM will be limited to no more than ten percent(10%) of the total monthly amount owed to IBM by Customer.

#### 3.0 NON-DISCLOSURE

3.1 Customer agrees not to disclose to third parties the terms and conditions or the existence of this Supplement, the Software, and the services provided to Customer under this Supplement except as required by law, provided Customer first allows IBM to review the proposed disclosure as it relates to IBM.

4.1 Some of the Software may be a pre-general availability version of IBM programs and documentation and may be changed by IBM prior to general availability and may not now be at the level of performance or capability of other generally available IBM products. The Customer accepts all risks that the IBM Software is not available on a timely basis and is not successful commercially.

6.1 This Supplement does not modify any other existing Supplement(s) between IBM and the Customer.
